NOTICE is hereby given that the Thirty-sixth (36th) Annual General Meeting ('AGM') of the Members of Blossom Industries Limited ('the Company') (CIN: U31200DD1989PLC003122) will be held on **Friday, August 22, 2025 at 10.30 a.m. (IST)** through Video Conferencing ('VC') facility / other audio visual means ('OAVM') ONLY, to transact the business as set out in the Notice of the AGM in accordance with the General Circular issued by the Ministry of Corporate Affairs dated 19th September, 2024 read with circulars dated September 25, 2023, December 28, 2022, May 5, 2020, April 8, 2020 and April 13, 2020 (collectively referred to as 'MCA Circulars'). - In case shares are held in physical mode, physical shareholders are requested to provide Folio No., Name of shareholder, scanned copy of the share certificate (front and back), PAN (self attested scanned copy of PAN card), AADHAR (self attested scanned copy of Aadhar Card)
- In case shares are held in demat mode, please provide DPID-CLID (16 digit DPID + CLID or 16 digit beneficiary ID), Name, client master or copy of Consolidated Account statement, PAN (self attested scanned copy of PAN card), AADHAR (self attested scanned copy of Aadhar Card).

Members holding shares in physical and who do not have login ID and password for remote e-Voting can either retrieve the initial password emailed to them on their registered email id and if their email id is not registered, then they may send email to evoting@nsdl.com mentioning their demat account number/folio number, PAN, name and registered address. Members can also use the OTP (One Time Password) based login for casting the votes on the e-Voting system of NSDL.
